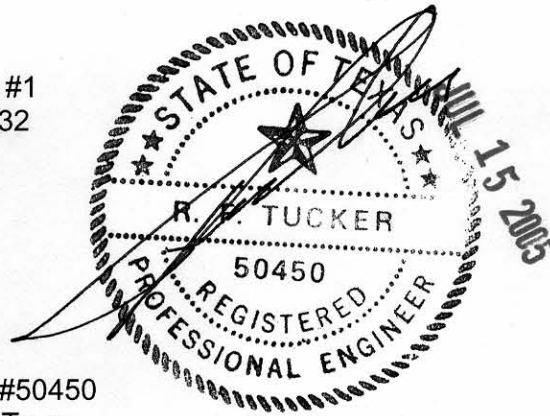

The Texas Department of Housing and Community Affairs (TDHCA) approves the AnchorPanel Foundation System for wind zone I and II for manufactured homes in Texas. Approval is based wholly upon the certification provided by Ray F. Tucker of the evidence submitted.

***Evidence Submitted***

Columbia Research and Testing Certification Report Number 0106-FT-0101503 (Issued 11/01/03. Installation Instructions modified 9/20/05. Certification Report Cover Sheet issued and sealed 7/15/05 by R.F Tucker) is the substantiating report.

***Description of Component/System***

The certification report describes the AnchorPanel Foundation-Wall Panels as a series of galvanized B-deck steel panels cast in-situ as load bearing foundation walls.

***Condition for Use of Component/System***

The Installation of the AnchorPanel Foundation System updated 9/20/05 must be used in accordance with the AnchorPanel Installation Instructions. Note that single-wide units using this system are not allowed in wind zone II.

Unless renewed, this approval letter and the TDHCA approval stamp on the enclosed certification report will expire on July 6, 2015. The Manufactured Housing Division Executive Director has the authority to withdraw approval of this component/system on an earlier date, if any of the conditions described in rule 10 TAC 80.62(g) exist.
